Guidelines to the School on Our Educational Service

To support best practice guidance from the Welsh Government, School Health and Wellbeing Coordinators are required to plan jointly with visitors to ensure the delivery of a well-planned coordinated programme. In each school both the Health and Wellbeing Coordinator and the Schools Police Officer (SPO) are required to complete a planning form together.

Delivery

The SPOs are able to provide sessions to raise awareness of substance misuse, safeguarding, social behaviour and community issues. Each lesson focuses on the legal and social aspects of the topic discussed and gives pupils opportunities to make positive choices. All information is accurate and up to date, age and ability appropriate and interactive. All lessons are delivered in a supportive manner and local and pupils are directed to relevant local and national support agencies and help lines. Follow up materials are available here on **SchoolBeat.cymru** for teachers and pupils.

Evaluation

Lesson observations are undertaken regularly by the WPSP Regional Coordinators to ensure a high standard of professionalism. To ensure that children, young people and teaching staff have a voice in evaluating the Programme various evaluative feedback methods are used in a sample of schools. The methodology involves questionnaires, focus groups, and interviews with the Health and Wellbeing Coordinator and a member of the SMT.
